  on out of region clients who have been placed locally for ITA treatment; this will allow TMBHASO to bill the outside regions for the ITA expenses.
- An RFP for an architect for the expansion at the long-term facility in Tumwater is beginning to get responses; the Thurston County Board of County Commissioners will review the responses once the deadline has been met.
- Compliance and OPMA training requirements will be sent to board members via email in the next month; proof of this training must be documented every four years.

#### **OHRS**

- Two new Designated Crisis Responders will be starting soon; the Trueblood program has hired a new Mental Health Professional to work out of the Thurston County Jail, and two more peers will be joining the Mason County LEAD and crisis programs.
- Mason County Public Health is providing COVID vaccinations for OHRS direct service staff.

- Mason County Law Enforcement Assisted Diversion (MCLEAD) referrals are increasing and OHRS staff have participated in recent syringe exchange programs to spread awareness of available treatment program options.
- Two Designated Crisis Responders (DCR) are splitting time and working with Olympia Police Department in the community, OPD is providing a desk for them and they respond to calls with police as needed.
- Funding for Trueblood client housing is being discussed and the opportunity to submit a grant application may be in the near future. Further talk with board members will be needed.
